No one should be discriminated against because of who they are

We can help anyone in North Wales who thinks that they may have been discriminated against. Don't delay taking action as there are often strict time-limits.

People who are protected by the law
Gay, straight, black, white, pregnant, male, trans, female, disabled, mental health issues, young, old, married or in a civil partnership, British, non-British, a person with faith or a person with no faith.
