(CIVIL ENFORCEMENT AND CONSOLIDATION) (AMENDMENT NO. 14) ORDER 2018

Notice is hereby given that on the 27th February 2018, Flintshire County Council made an Order in exercise of its powers under the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, Part IV of Schedule 9 and all other enabling powers, the effect of which will be to amend The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013, and:

- (1) To introduce 'No Waiting at Any Time' restrictions on both sides of Kent Road, Connah's Quay for its entire length.
- (2) To introduce 'No Waiting at Any Time' restrictions' at the junction of Clifton Park Avenue, with Hafod Park, Connah's Quay.
- (3) To introduce 'No Waiting Monday to Friday 8.30am 9.30am and 2.30pm 4.00pm' restrictions on the Easterly side of Clifton Park Avenue, Connah's Quay.
- (4) To introduce 'No Waiting restrictions Monday to Friday 8.30am 9.30am and 2.30pm 4.00pm on York Road, Connah's Quay.
- (5) To introduce 'No Waiting at Any Time' at the junctions of York Road with Clifton Park Avenue, Queens Avenue, Hamilton Road and Kent Road, Connah's Quay.

In all other respects the present provisions of the 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013' will remain in force.

A copy of this Notice, the Order which will come into operation on the 9th March 2018, plans showing the roads affected and a statement of the Council's reasons for the making of the Order, may be inspected during normal opening hours at Connah's Quay Post Office, Unit 6 Red Hall Precinct, Connah's Quay, CH5 4TS and Flintshire County Council, Alltami Depot, Mold Road, Alltami, Flintshire CH7 6LG during office hours, where the Order proposed to be amended will be available for inspection. The documents will also be available to view on www.flintshire.gov.uk

If you wish to question the validity of the order or any of its provisions on the grounds that any requirements of the Act or any instruments made under it has not been complied with, you may, within 6 weeks from the date on which the order is made, apply for the purpose to the High Court.
