Likewise, I have worked with Holywell Town Council and fellow councillors to promote initiatives that support the revitalising of the town centre and High Street such as Square and the, de-pedestrianisation pilot project. I have similarly worked with colleagues to develop the infrastructure to support the long-term future of Holywell such as building better links with external agencies such as GoNorthWales.

I remain concerned about the speed limits and parking issues along Halkyn Road, Fron Park Road and Holway Road and that this road can be used as a diversionary route for the A55 when roadworks are undertaken. I also remain committed to ensuring that issues of anti-social behaviour including things like fly-tipping etc. are addressed throughout the ward.
