#### **Eglurhad o'r Angen**

Mae'r Papur Cefndir yn egluro sut cafodd Asesiad Safle Teithiwy'r Sipsi 2016 y Cyngor (GTAA) ei gymeradwyo gan Lywodraeth Cymru. Mae'r Papur Cefndir hefyd yn cyfeirio at ganfyddiadau diweddariad dilynol y GTAA yn 2018. Mae Llywodraeth Cymru yn dilyn hynny wedi cynghori nad yw diweddariad 2018 y GTAA ar gael i'w gymeradwyo gan Lywodraeth Cymru gan mai diweddariad rhannol ac nid GTAA llawn ydoedd. Fodd bynnag, mae Llywodraeth Cymru wedi cadarnhau fod GTAA 2016 yn berthnasol i gyfnod y Cynllun a bydd yn ddigonol ar gyfer paratoi ar gyfer y cynllun, gan ei fod yn parhau yn GTAA a gymeradwywyd i Sir y Fflint (gweler yr e-bost isod gan Kate Rose, Rheolwr Polisi Sipsi a Theithiwr, Yr Is-Adran Gymunedau, Llywodraeth Cymru. Mae'r angen a nodwyd ar gyfer lleiniau preswyl y Sir felly yn parhau'n 5 llain am gyfnod o 5 mlynedd ac 19 llain ar gyfer cyfnod y Cynllun.

Having reviewed the extant approved GTAA ([online link](#)) I can confirm that in sections 5.48 and 5.49 the "plan period" calculations do refer explicitly to 2030. The current GTAA remains extant until a new GTAA is approved. I have consulted with colleagues in the Welsh Government Planning branch and I can confirm that the extant approved GTAA will suffice for LDP preparation.

We agree that it is unfortunate that use of the extant approved GTAA means that the additional need set out in the update you provided will not form part of the LDP. However, we understand that the LDP will not prohibit site development to meet any additional need evidenced in a future GTAA.

Dear Kate

Thank you for your email regarding the Flintshire GTAA.

Given the last contact was July 2019 a lot has happened in the interim including the publication and consultation of the Deposit Flintshire LDP where in commenting on the GTAA, your development plan team colleagues have raised the issue of resolving the status of the GTAA update.

Whilst I have reviewed John's initial comments from last July they didn't really explain the basis for concerns or explain how the update didn't comply with guidance. Equally no formal request for clarification was subsequently sent despite being referenced in John's email.

It is clear that having allowed so much time to elapse before contacting us now, you have not allowed sufficient time for the Council to carry out a further full GTAA that will allow us to keep to our LDP delivery Agreement with Welsh Government. Neither do we have the resource given we had already committed to work by Arc4 our consultants who carried out the original GTAA and the 2018 update.

Given that John was essentially saying our 2018 update was not compliant, what would be the point of you now scrutinising the submitted GTAA if it is likely to fail? Equally you have not said what would be required to make it compliant. Also if you will not look at it until after April that will further disadvantage the Council in its ability to

meet its obligation to Welsh Government in terms of the LDP Delivery Agreement and how the GTAA will support the LDP as evidence at examination later this year. To that extent you are placing us in a knowingly invidious position.

It would be good if you could simply confirm as soon as possible that the agreed GTAA is still current until 2021 when it is my understanding that it would require full review. On that basis it would serve as the evidence base for the LDP examination, notwithstanding that it shows a lesser need than that identified in the Update, which seems perverse to me.

I'm happy to discuss this further with you.

Dear Andy,

I'm just writing to provide you with a quick update on the process of scrutinising your submitted GTAA, as I appreciate that you will need to manage your own timescales. As you are aware, we are currently undertaking the annual progress and compliance review of all extent, approved GTAAs - an exercise which commenced late due to the previous staff resourcing situation and which should be complete by 1 April. We will therefore be prioritising the scrutiny of new GTAAs from 1 April. At this stage it's not possible to give an indication of how long scrutiny will take to complete, not least because additional Assessments are being submitted on an ongoing basis, however you can expect to hear from us in due course in the next financial year.

Mindful of the comments provided by John below, of which I am not aware of a response to, could you confirm you wish us to undertake formal scrutiny of the document submitted last year against the full requirements outlined in our guidance?
