

Hopefully you have already informed me if you wish to participate in any hearing sessions you are entitled to, so once the Draft Programme is available please do carefully check it.


I have tried to assign participants to the most appropriate sessions based on their representations but if you think you have been put into too many, too few or wrong sessions please contact me asap.
