However, the level to which they will be learning Cymraeg will be to courtesy level Welsh supporting them to pronounce Welsh place names and personal names correctly. It ensure there is an opportunity to learn Cymraeg in a supportive environment and increase future career opportunities in Cymru.

Being able to speak Welsh is a valuable employment skill in Wales, particularly in the public sector. Developing employees confidence in using Welsh will be beneficial if employees seek promotion. Training will be provided in a variety of ways and employees will not be expected to incur costs.

Increasing the number of employees who can speak Welsh will increase the number of bilingual Council services that are available

The implementation of the strategy will reinforce the importance of Welsh language and the links to customer care. There can be polarised attitudes towards the Welsh language and this will help promote common understanding and supportive attitudes towards Cymraeg.

The aim of the strategy is to increase the number of employees speaking /understanding Welsh, at all levels of the language framework. An increased number of employees using Welsh will increase the visibility and audibility of Cymraeg. An increased number of Welsh speaking employees which have a positive impact on the availability an quality of bilingual Services. This in turn will lead to an increased opportunity for members of the public to use Welsh with the Council.
