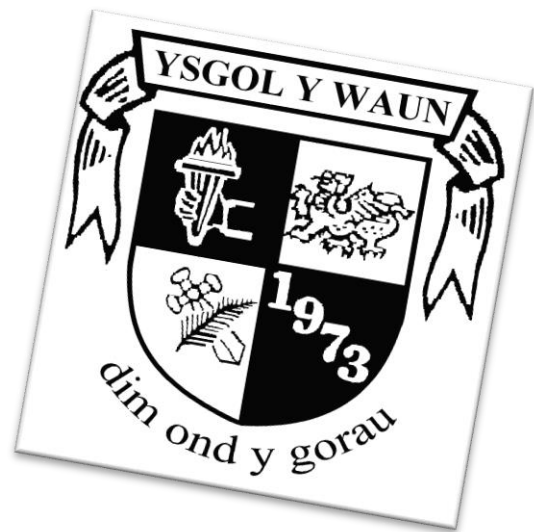


FEDERATION CONSULTATION REPORT



**Proposed Federation between

Thursday 1st February 2018**

1. Summary

This reports shows that the proposal to federate Gwernymynydd Community Primary School and Ysgol Y Waun, Gwernaffield is overwhelmingly supported by those people who submitted a response to the consultation.

There was a reasonable number of responses, with the majority received from people associated with Gwernymynydd Community Primary School. No alternative suggestions were offered and over half of the comments received showed that people believed federation is the best way to ensure the schools remain in their respective communities.

Children at both schools were also consulted and encouraged to give their views on the proposal. Most of the comments can be viewed as positive, however there were some neutral comments and some negative comments.

2. Introduction

The governing bodies of Gwernymynydd C.P. School and Ysgol Y Waun, Gwernaffield, propose that both schools enter a federation agreement from Thursday 1st February 2018, in accordance with the Federation of Maintained Schools (Wales) Regulations (2014).

A Federation Consultation Document was produced to provide an overview of both schools and to explain why changes have been put forward. The document also outlined the benefits and the challenges of federation as well as the process from exploration to implementation and evolution.

The consultation period opened 23rd May 2017 and closed on 10th July 2017, with events held at each school where Head Teachers, Governors and representatives from the Local Authority were on hand to explain the situation and answer any questions from attendees. Separate consultation sessions were held with children from each school.

Response forms were created to allow children, parents, carers, governors, staff and community members to give their views about the proposals. This document analyses the responses to the consultation received both online and in hard copy form.

3. Consultation Process

Following the publication of the proposal to federate, a statutory 6 week consultation period began with parents / carers and all key stakeholders either receiving a hard copy of the Formal Consultation Document or emailed a link to the document on the Flintshire County Council website.

Although there is not a requirement to do so under the Regulations, consultation meetings were held at each school on the following dates:

- Ysgol Y Waun, Gwernaffield on Tuesday 13th June 2017, 3:15pm - 6.00pm
- Gwernymynydd C.P. School on Wednesday 14th June 2017, 3:15pm - 6.00pm

People were encouraged to complete a response form (see Appendix A) to express their views about the proposal, with hard copies included as part of the Formal Consultation Document and an online version if people wanted to complete it electronically.

The Formal Consultation Document was converted into a child-friendly version to allow each school to consult with representatives of their pupils. Head Teachers ran their own events and had pupils complete specifically designed response form (see Appendix B) to provide their views.

All responses to the consultation can be found in Appendix C and have been summarised in the Findings section below. Children's comments have also been outlined below in section 5.

4. Findings

4.1. Relationship to the Schools

In total 45 people submitted a response during the consultation period, with 33 (73%) identifying themselves as associated with Gwernymynydd CP School and 12 (27%) connected to Ysgol Y Waun, Gwernaffield.

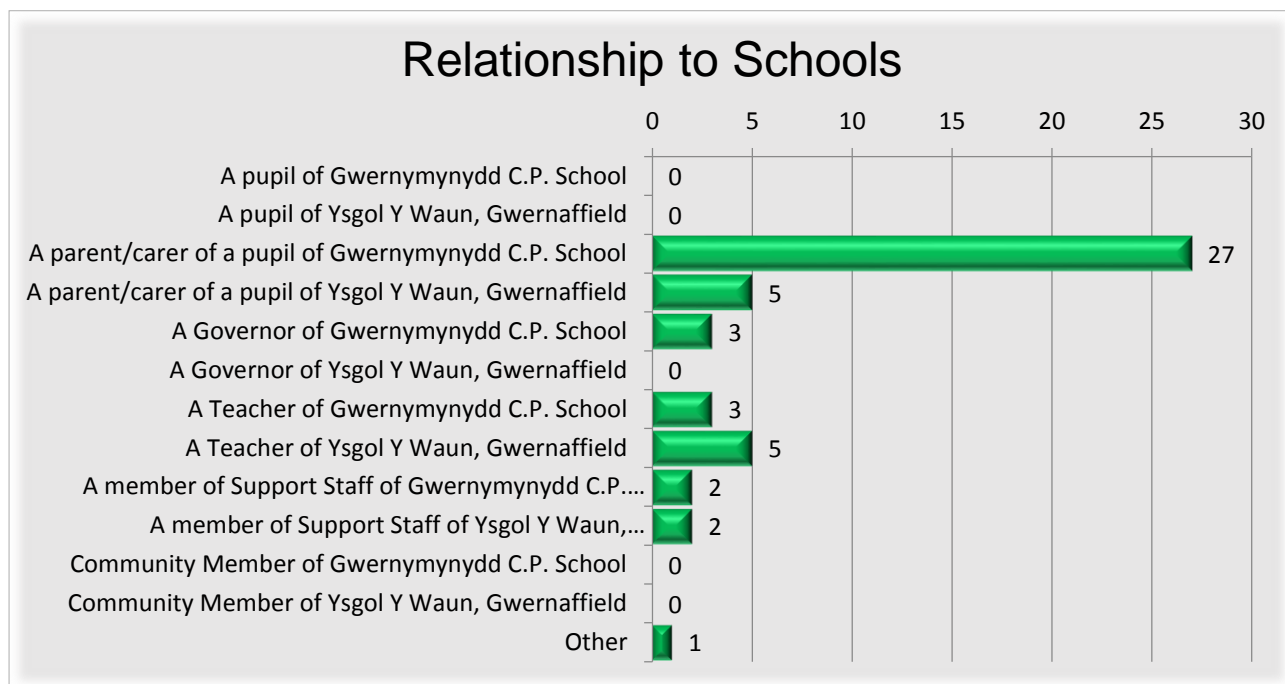


Figure 1: Relation to Schools of Respondent's

Figure 1 shows a breakdown of how respondents described their relationship to their respective school (it should be noted that three people selected more than one option and therefore both of their responses have been included in Figure 1).

4.2. Support for the Proposal

People were asked to state whether they agreed with the proposal to federate Gwernymynydd C.P. School & Ysgol Y Waun, Gwernafield as of 1st February 2018.

There was unequivocal support for the proposal with 44 people (97.78%) declaring that they were in favour of establishing a federation between the two schools. One person declined to answer the question stating that they were “undecided”.

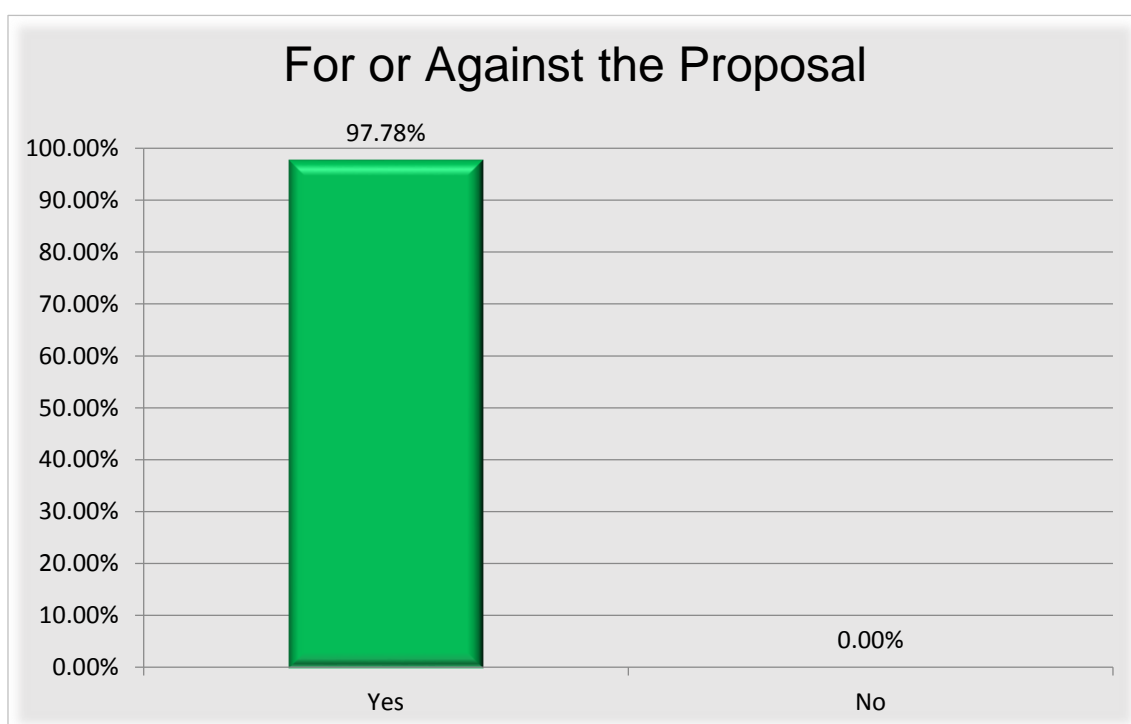


Figure 2: For and Against the Proposal

4.3. Alternative Proposals and Additional Comments

Respondents to survey had the opportunity to outline alternative proposals for sustainable education provision in the area. Only 7 people however answered the question, either making a general comment or simply stating “No”.

People were also invited to provide any additional comments regarding the proposal and 18 people gave a variety of views which have been summarised in Table 1 below.

5. Children’s Consultation

Both schools ran a number of sessions with their children to obtain their views on the proposals. During the sessions children were asked to complete a short questionnaire to say how they felt about the proposal, if there is anything else they would like to see instead and if they would like to say anything else.

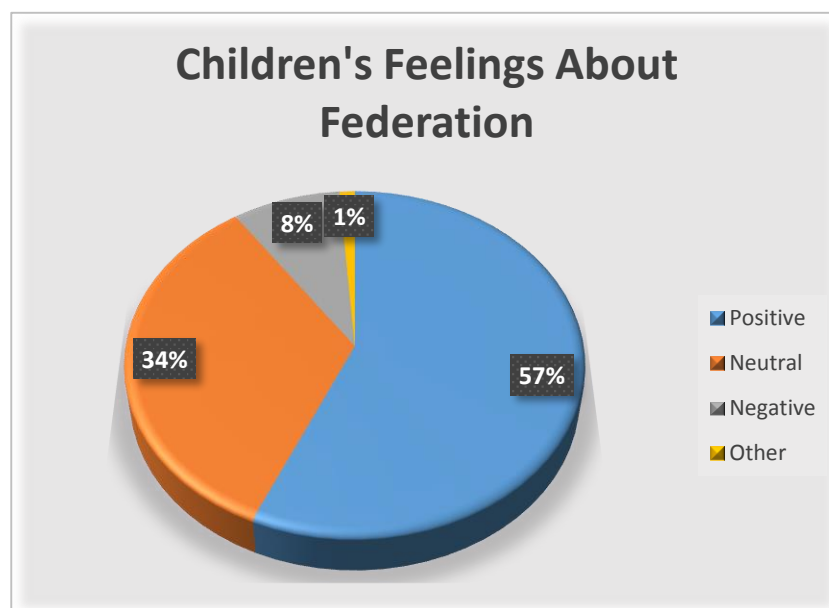


Figure 3: Children's Feelings

5.1. Gwernymynydd C.P. School

There were 33 children from Gwernymynydd C.P. School who gave their opinion via the response form. 20 children felt positive about the proposal, highlighting the possibility of making new friends and sharing a head teacher as reasons why. Comments included *“I think sharing a head teacher is a good idea”* and *“I think it would be a good idear because it would be nice to make friends with Ysgol y Waun”*.

10 neutral responses had general comments such as *“I would feel fine”* and *“OK”*, whilst there were only 3 negative comments which included one child being nervous about change and one suggesting pupils at Ysgol Y Waun were mean on a joint school trip.

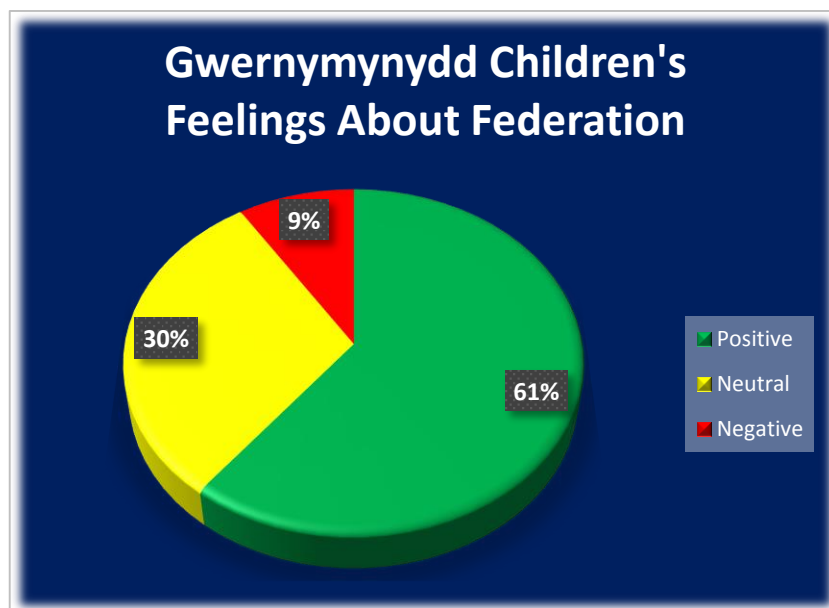


Figure 4: Gwernymynydd Children's Feelings

There were 2 alternatives put forward by children, one stating *“us keep are head teacher and not join schools”* and the other suggesting to *“fedirate with bryn coch because my football friends our there”*. There were more general comments like *“No”* and *“I would like Mr Johnson to be head teacher”*.

Of the additional comments some children wanted to know about teaching arrangements such as *“If it didn’t work out as Mrs Ankers as head teacher would Mr Johnson stay head techer”* and *“Will Miss Parry still teach us on mondays”*. One pupil suggested playing other sports like lacrosse and cricket whilst another child wrote *“It would be nice to have more things like the slide. And willow den”*.

5.2. Ysgol Y Waun, Gwernaffield

Of the 50 pupils from Ysgol Y Waun who completed a questionnaire, 27 felt positive toward federation with comments such as *“Happy because we will be stronger”*, *“I would feel happy to make more friends”* and *“I will fill happy ☺”*.

18 of the remaining questionnaires provided neutral comments such as *“I would feel perfectly fine”* and *“it would be the same to me”*. There was 1 child who chose not to answer the question, whilst 4 felt negatively about the proposal, with comments such as *“I think we are fine how we are as Ysgol Y Waun”* and *“I would fell a lit confused because were fine on our own and I enjoy this way”*.

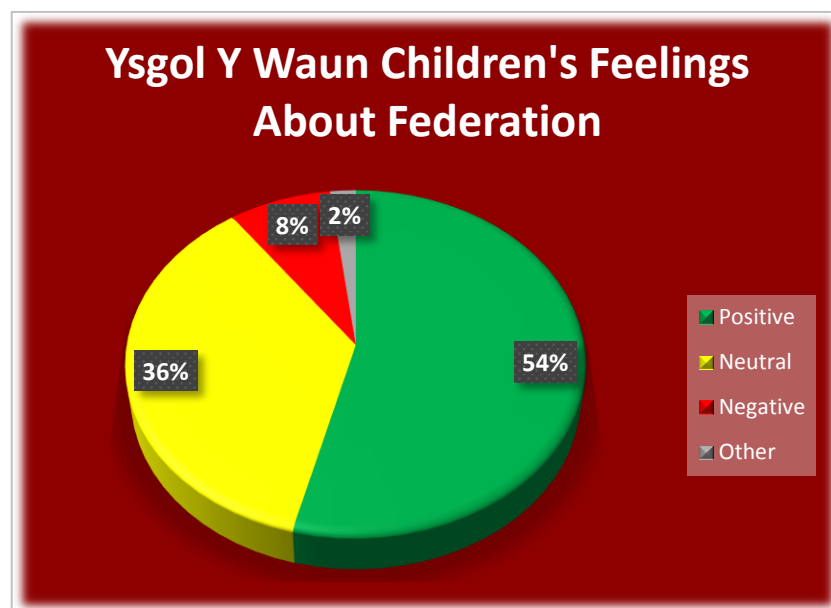


Figure 5: Ysgol Y Waun Children's Feelings

The majority of comments suggesting something else instead of the proposal were *“no”* or *“not really”*, whilst there were general comments like *“Ysgol Y Waun can invest in new equipment”* and *“a bigger sportday”*.

Additional comments made by children either mentioned more school trips together or joint sports teams and activities. Specific examples include *“have a joint sports day”*, *“can we have a joint sports day and trips?”* and *“more school trips please”*.

6. Conclusion

There is clear support from respondents for a formal federation between Gwernymynydd C.P. School and Ysgol Y Waun, Gwernafield to be established. This option is viewed as the best way of keeping the schools in the local area whilst retaining their own individual identities.

7. Proposal Consideration

Part 2 Regulation 7 of the Federation of Maintained Schools (Wales) Regulations (2014) states that:

- 1) The governing bodies proposing to federate must jointly consider any responses to the proposals and each governing body must determine whether
 - a) to proceed with the proposals for federation as published;
 - b) to proceed with the proposals for federation with such modifications as the governing body considers appropriate; or
 - c) not to proceed with the proposals for federation.
- 2) The modifications referred to in paragraph (1)(b) must not include a change in the identity of the governing bodies proposing to federate.
- 3) All the governing bodies that have determined to proceed must jointly give notice of that fact to the relevant local authority or local authorities

In accordance with the Regulations, the governing bodies of Gwernymynydd C.P. School and Ysgol Y Waun, Gwernafield will hold a joint meeting to consider this report and make a final decision whether or not to proceed with the proposal.

Flintshire County Council have agreed to provide a neutral venue for the meeting, which will take place between 6:00pm and 7:00pm on Monday 17th July 2017 at County Hall, Mold.

This report is to be circulated to the governing bodies prior to the meeting.
