- (a) The removal of sections of No Waiting At Any Time restrictions:-
- 1. On the A541 High Street, Caergwrle Lay-by, outside property numbers. 45, 47, 47a and The Glynne Residential Home.

A section of No Waiting At Any Time restriction, will remain outside the rear access to property number 47.

In all other respects the present provisions of the 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013' will remain in force.

A section of No Waiting At Any Time restriction will remain outside the rear entrance to property number 47, to keep this access point clear.

The removal of double yellow lining at this location, will benefit the local shops and businesses in the area, by providing an area of parking for visitors, off the main carriageway and will therefore assist in the free flow of traffic for all vehicles.


