#### **EXPERIMENTAL ORDER**

Notice is hereby given that on the 27<sup>th</sup> February 2024, Flintshire County Council (hereinafter referred to as "the Council") made an Experimental Order in exercise of its powers under Section 9, 10 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") the effect of which will be to:-

- Suspend the 'No Waiting 7am 7pm' restrictions on parts of Mold Road, Buckley contained within 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013
- 2. Introduce on an Experimental basis 'No Waiting at Any Time' restrictions on the following length of road:
  - (a) on part of both sides on Mold Road, Buckley
- 3. Introduce on an Experimental basis 'Limited Waiting bays for 20 minutes, No return within 1 hour' on the following length of road:
  - (a) On the north side lay-by on Mold Road, Buckley
- 4. Introduce on an Experimental basis 'Bus Clearway' restrictions on the following length of road:
  - (a) On the north and south side lay-by's on Mold Road, Buckley

In all other respects the present provisions of the 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013' will remain in force.

The Experimental Order will come into operation on the 8th March 2024 for a period of 18 months. A copy of the Order, together with a plan showing the length of roads to which the Order relates and a statement of the Council's reasons for making the Order, may be examined at Flintshire Connects, Buckley Library, The Precinct, Buckley, Flintshire, CH7 2EF, during opening hours or they may be viewed on our website at www.Flintshire.gov.uk > Resident > Roads, Streets and Travel > Traffic Regulation Orders or you can request a copy of the documents by emailing Streetscene@flintshire.gov.uk or by calling 01352701234.

The Council will be considering, in due course, whether the provisions of the Order should be continued in force indefinitely. Within a period of 6 months from the coming into force of the Order, or if the Order is subsequently modified or varied, from the coming into operation of that modification or the variation (whichever is the latest), any person may object to the making of the Order for the purposes of such indefinite continuation.

Objections to the Order, together with the grounds on which they are made, should be sent in writing to the undersigned within six months of the date on which this Order shall have come into

force, or the date on which any variation or modification or the latest variation or modification shall have come into force and quoting the reference SS/TRO/JB/EO-63/2024.

If it appears essential to the Council that it is necessary in the interests of the expeditious, convenient or safe movement of traffic or of the provision of suitable and adequate parking facilities on the highway or for preserving or improving the amenities of the area through which any length of road affected by the Order runs, then the nominated officer of the Council below, may modify or suspend the Order or any provisions thereof.

Any person wishing to question the validity of the Experimental Order (which was made on the **27**<sup>th</sup> **February 2024**) or any of the provisions contained in it on the grounds that they are not within the powers conferred by the appropriate legislation, or on the grounds that any requirement of such legislation, has not been complied with in relation to the Order may, within six weeks from the **27**<sup>th</sup> **February 2024**, apply to the High Court for this purpose.

Flintshire County Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 9, 10 of the Road Traffic Regulation Act 1984 ("the Act of 1984") as amended, the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

#### SECTION 1 - PRELIMINARY

#### Citation and commencement

- This Order shall come into operation on the 08<sup>th</sup> March 2024 and may be cited as The Flintshire County Council (Mold Road, Buckley) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) (Amendment No 63) Experimental Order 2024
- With effect from the date set out in Article 1 above, The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013 shall be amended insofar as it relates to the roads specified in the First Schedule to this Order and by the suspension of the Map Schedules specified in the Second Schedule to this Order and the insertion of the Map Schedules specified in the Third Schedule to this Order
- In all other respects the present provisions of The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013 will remain in force.
- 4. The interpretation Act 1978 shall apply for the interpretation on this Order as it applies for the interpretation of an Act of Parliament

- 5. In this Order, except where otherwise stated, any reference to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number and any reference to a plan is reference to a plan incorporated into this order.
- 6. In pursuance of section 10(2) of the Road Traffic Regulation Act 1984, the Chief Officer (Streetscene and Transportation) may, if it appears to that officer essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for preserving or improving the amenities of the area through which any road affected by this Order runs, modify or suspend the Order or any provisions thereof.
- 7. This Order shall continue in force for a period not exceeding 18 months from the date specified in Article 1 of this Order or until it is made permanent.

#### **EXPERIMENTAL ORDER 2024**

#### Statement of Reasons for Proposing to Make the Order

On the 27<sup>th</sup> February 2024, Flintshire County Council made an Experimental Order to introduce No Waiting at Any Time restrictions (double yellow lines), Bus Stop Clearways and Limited Waiting bays.

The measures will improve safety for all road users through the removal of parked vehicles at key locations, address indiscriminate parking, maintain visibility, whilst also improving traffic flow on Mold Road, Buckley.

The measures introduced will assist Public Transport vehicles, who are having difficulties travelling on Mold Road, due to the presence of inconsiderately parked vehicles.

In the interests of road safety, the proposals are necessary to avoid danger to people or other traffic using the road, or preventing danger arising.

The proposals are detailed in the Public Notice and in the proposed Order






