

## **Notice of Making**

### **B5122 SOUTH STREET, B5122 NORTH STREET, CHAPEL STREET, WATER STREET, HIGH STREET, DROVERS LANE AND HOLYWELL ROAD, CAERWYS PROHIBITION OF WAITING AT ANY TIME**

Notice is hereby given that on the 10<sup>th</sup> June 2025, Flintshire County Council made an Order in exercise of its powers under the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, Part IV of Schedule 9 and all other enabling powers, the effect of which will be to amend The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013, so as to:

1. Introduce 'No Waiting at Any Time' restrictions:-
  - a. At the junction of the B5122 South Street with Chapel Street, Caerwys.
  - b. At the junction of the B5122 North Street with Drovers Lane, Caerwys.
  - c. At the junction of the B5122 North Street with High Street, Caerwys.
  - d. At the junction of the B5122 North Street with Water Street, Caerwys.
  - e. At the junction of the B5122 North Street with Holywell Road, Caerwys.

In all other respects the present provisions of the 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013' will remain in force.

Should you wish to view a copy of this Notice, the Order which will come into operation on the 04<sup>th</sup> July 2025, plans showing the roads affected and a statement of the Council's reasons for the making of the Order, they may be inspected during normal opening hours at Flintshire Connects, Mold Library, Earl Road, Mold, Flintshire CH7 1AP. Flintshire County Council in exercise of its powers under sections 1 (1), 2 (1)(2), 4 (2)(3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") as amended, the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

**SECTION 1 – PRELIMINARY**

**Citation and commencement**

1. This Order shall come into operation on the 04<sup>th</sup> July 2025 and may be cited as The Flintshire County Council, B5122 South Street, B5122 North Street, Chapel Street, Water Street, High Street, Drovers Lane and Holywell Road, Caerwys, (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) (Amendment No. 70) Order 2025
2. With effect from the date set out in Article 2 above, Map Schedules N59 Sheet Revision No: 2, replaces Map Schedules N59 Sheet Revision No: 1 respectively and all other map schedules together with the before mentioned map schedules and plans referred to in the Schedules to this Order are incorporated into The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013.
3. The interpretation Act 1978 shall apply for the interpretation on this Order as it applies for the interpretation of an Act of Parliament
4. In this Order, except where otherwise stated, any reference to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number and any reference to a plan is reference to a plan incorporated into this order.



**PROHIBITION OF WAITING**

**Statement of Reasons for Make the Order**


Flintshire County Council propose to introduce No Waiting at Any Time restrictions (double yellow lines) in the roads as listed above.

The introduction of the No Waiting At Any Time restrictions are intended to address indiscriminate parking, maintain visibility and to ensure that the junctions are not obstructed by parked vehicles

Parking at junctions, regardless of the presence of yellow lines, is an offence and the restrictions provide a visual deterrent to reinforce this message. At present, should vehicles be parked within 10 metres of a junction, an act of criminality may be committed and would therefore be subject to enforcement action by North Wales Police. Furthermore the Highway Code states that vehicles should not park near or on a junction as they may cause obstruction and compromise safety for all road users.

The County Council continues its responsibility to consider the provision of convenient and safe movement of motor vehicles and other traffic, and the measures are aimed at ensuring that danger is minimised to vulnerable road users aswell as improving the amenities of the locality.
