SECTION 23 OF THE ROAD TRAFFIC REGULATION ACT 1984

PROPOSED CROSSINGS ON ST DAVIDS INTERCHANGE ROUNDABOUT, EWLOE

NOTICE is hereby given that the Flintshire County Council, in exercise of its powers under Section 23 of the Road Traffic Regulation Act 1984 and all other enabling powers proposes:-

- a) The installation of a Parallel / Cycle and Pedestrian Crossings at the location as described in the Schedule to this Notice.

Reason for Proposal: Flintshire County Council has identified St Davids Interchange Roundabout, Ewloe as a suitable location for a Parallel / Cycle Crossing facility. The implementation of the proposed active travel improvements, serves as an integral element to a much wider integrated transport proposal and package of schemes currently underway within the locality. Not only will the scheme provide essential access between Shotton, Queensferry, Ewloe and Hawarden, it will also form a key aspect of a wider strategic Active Travel corridor enabling access to schools, services and wider proposals (i.e. NMWTRA Active Travel proposals along the A494 / access to public transport at key hubs for onward travel to key employment sites). The proposals will provide an affordable sustainable transport corridor for local people, particularly for those without access to a car. This will provide safer, sustainable access to education, employment and other services and facilities which are currently difficult to access

The usual prohibition of vehicles stopping, waiting, loading and unloading on the carriageway within the areas marked by Zig Zag lines on either side of the crossing will apply.



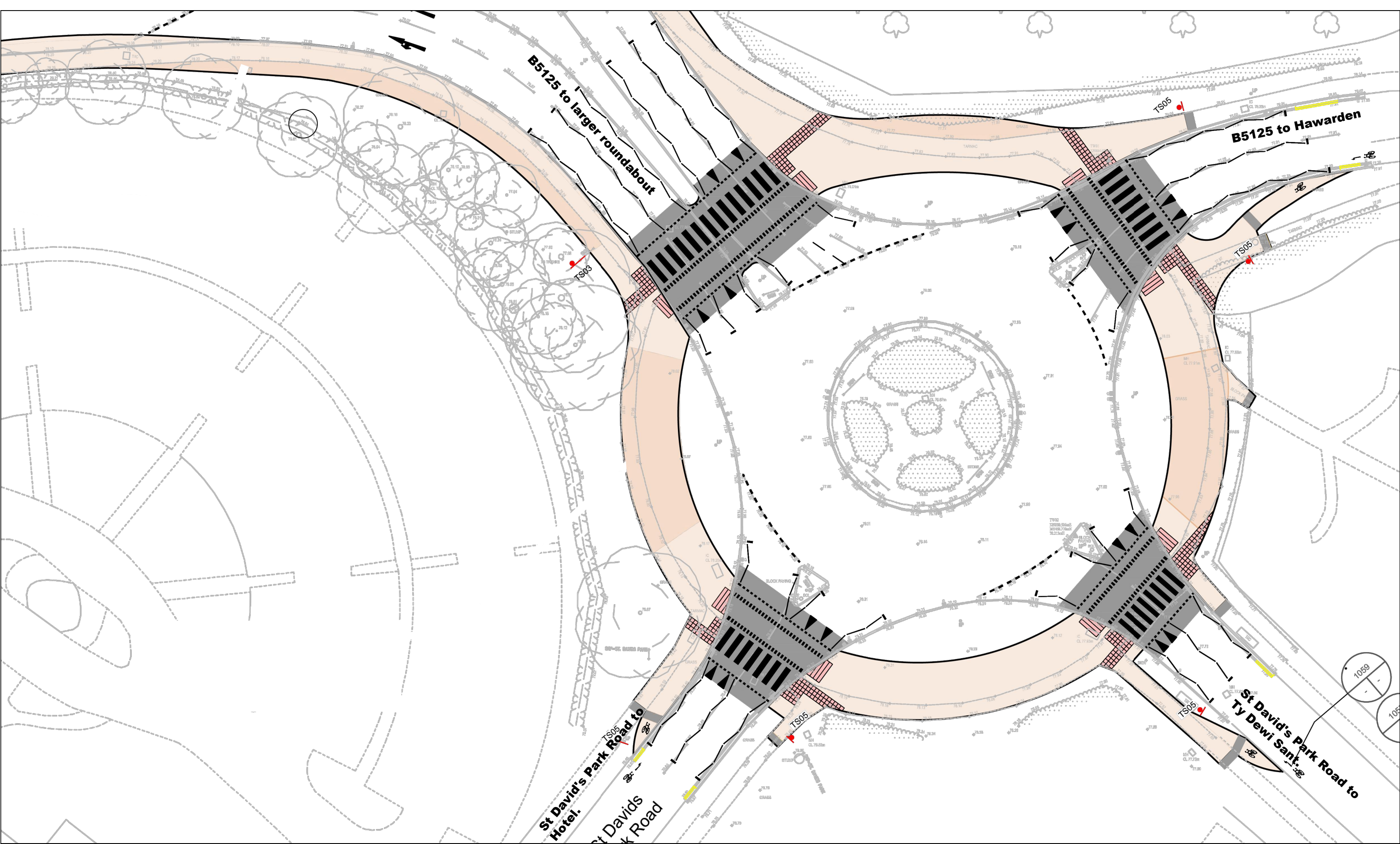
