PROPOSED PROHIBITION OF WAITING AT ANY TIME

Flintshire County Council propose to make an Order in exercise of its powers under the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, Part IV of Schedule 9 and all other enabling powers, the effect of which will be to amend The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013, so as to introduce:-

- 1. 'No Waiting At Any Time' restrictions-:
 - a. At various locations on both sides of the A5026 Bagillt, in the vicinity of Ysgol Glan Aber.
 - b. At the junction of the A5026 with Bron Haul, Bagillt

In all other respects the present provisions of the 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013' will remain in force.

SECTION 1 – PRELIMINARY

Citation and commencement

With effect from the date set out in Article 1 above, Map Schedule AD44 Sheet Revision No: 2 replaces Map Schedule AD44 Sheet Revision 1 and Map Schedule AD45 Sheet Revision No: 2, replaces Map Schedules AD45 Sheet Revision No: 1 and all other map schedules together with the before mentioned Map Schedules and plans referred to in the Schedules to this Order are incorporated into The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013.
- 3. The interpretation Act 1978 shall apply for the interpretation on this Order as it applies for the interpretation of an Act of Parliament
- 4. In this Order, except where otherwise stated, any reference to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number and any reference to a plan is reference to a plan incorporated in to this order.

PROPOSED PROHIBITION OF WAITING

Statement of Reasons for Proposing to Make the Order

Flintshire County Council propose to introduce No Waiting at Any Time (double yellow lines) in the roads as listed above.

The No Waiting At Any Time restrictions are intended to address indiscriminate parking, maintain visibility and to ensure that junctions, footways and crossing points are not obstructed by parked vehicles.

Parking at junctions, regardless of the presence of yellow lines, is an offence and the restrictions provide a visual deterrent to reinforce this message. At present, should vehicles be parked within 10 metres of a junction, an act of criminality may be committed and would therefore be subject to enforcement action by North Wales Police. Furthermore the Highway Code states that vehicles should not park near or on a junction as they may cause obstruction and compromise safety for all road users.

The Introduction of Waiting restrictions, will improve pedestrian safety through the removal of parked vehicles at key locations, whilst reducing congestion and improving traffic flow around the Ysgol Glan Aber.


The Authorities primary concern is for the safety and wellbeing of the general public, including Children going to and from School. By providing a safe environment for pedestrians, this reduces the risk of accidents occurring between vulnerable users and motor vehicles and will facilitate the uptake of Active modes of Travel for pupils attending Schools within the area.






