Statement of Reasons for Proposing to Make the Order

A541 Junction with the B5102:

The A541 junction with B5102 in Cefn Y Bedd has an historic collision record consisting of but not limited to, vehicles pulling out into the path of oncoming traffic, rear end shunts on approach to the junction and Right turn manoeuvres often resulting in injuries to those involved or near misses. In addition to the above issues associated with the junction, there was also no pedestrian provision for accessing local amenities.

Therefore Flintshire County Council have obtained grant funding from Welsh Government to deliver a road safety scheme at this location.

The proposal will include the provision of a signalised / pedestrian crossing junction improvements at the A541/B5102, Cefn y Bedd, which will greatly improve safety at this location. By introducing pedestrian facilities at the junction, it will reduce conflict between different vehicle movements. As a result it is proposed to reduce the speed limit from 40 mph to 30 mph at this location to accommodate the signalised / pedestrian crossing.

It is felt the reduction in speed limit and provision of traffic signals will reduce the number of reported accidents and improve road safety. The speed limit reduction will also reduce vehicle speeds on the approach to the pedestrian crossing in line with the visibility available.




