Notice is hereby given that on the 05th July 2022, Flintshire County Council made an Order in exercise of its powers under the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, Part IV of Schedule 9 and all other enabling powers, the effect of which will be to amend The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013 so as to introduce:

No Waiting At Any Time restrictions -:

- 1. At various locations on both sides of Elfed Drive near Potters Way and Beechtree Road Junctions.
- 2. At various locations on both sides of the B5127 Mill Lane.
- 3. At various locations on both sides Tabernacle Street.
- 4. At various locations on both sides of Padeswood Road North.
- 5. At the junction of Elfed Drive with Potters way
- 6. At the junction of Elfed Drive with Beechtree Road.
- 7. At the junction of Tabernacle Street with Padeswood Road North.
- 8. At the junction of Tabernacle Street with Orchard Close.
- 9. At the junction of the B5127 Mill Lane with Hawkesbury Road near to Elfed School.
- 10. At the junction of the B5127 Mill Lane with Elfed School / Sports Centre Service Road.
- 11. At the junction of Mill Lane with Padeswood Road North.
- 12. At the junction of Mill Lane with Brunswick Road.
- 13. At the junction of Mill Lane with Mold Road.

In all other respects the present provisions of the 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013' will remain in force.

SECTION 1 - PRELIMINARY

Citation and commencement

With effect from the date set out in Article 1 above, Map Schedule AS94, Sheet Revision No: 2 replaces Map Schedule AS94 Sheet Revision 1, Map Schedule AS93 and AR93, Sheet Revision No: 3, replaces Map Schedules AS93 and AR93 Sheet Revision No: 2 and Map Schedule AS92 Sheet Revision No: 4, replaces Map Schedules AS92 Sheet Revision No: 3 respectively and all other Map Schedules together with the before mentioned Map Schedules and plans referred to in the Schedules to this Order are incorporated into The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013.
- 3. The interpretation Act 1978 shall apply for the interpretation on this Order as it applies for the interpretation of an Act of Parliament

PROPOSED PROHIBITION OF WAITING AT ANY TIME

Statement of Reasons for Proposing to make the Order

A successful bid was made to the Welsh Government and as such Flintshire County Council have been successful in obtaining funding to implement a safe route to school and active travel route through Buckley connecting to each of the schools.

The Introduction of the proposed Prohibition of Waiting At Any Time restrictions will improve safety for pedestrians and all road users through the removal of parked vehicles at key locations, whilst also improving traffic flow around Buckley. It will also ensure access is maintained for residents, prevent obstruction, maintain visibility at the junctions and also to ensure that the junctions are not obstructed by parked vehicles.

Parking at junctions, regardless of the presence of yellow lines, is an offence and the restrictions provide a visual deterrent to reinforce this message. At present, should vehicles be parked within 10 metres of a junction, an act of criminality may be committed and would therefore be subject to enforcement action by North Wales Police. Furthermore the Highway Code states that vehicles should not park near or on a junction as they may cause obstruction and compromise safety for all road users.

The County Council continues its responsibility to consider the provision of convenient and safe movement of motor vehicles and other traffic, and the proposed measures are aimed at ensuring that danger is minimised to vulnerable road users aswell as improving the amenities of the locality.


