1) To prohibit any vehicle, Except for Access and Cyclists, from entering Kiln Lane, Hope, from its junction with the A550 Hawarden Road, in an Easterly direction.

The Flintshire County Council in exercise of its powers under Sections 1, 2 and 3 of the Road Traffic Regulation Act 1984, ("the Act of 1984") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

- Save as provided in Article 2 to this Order no person shall cause any vehicle except for access to proceed in that length of road specified in Column 1 to the Schedule to this Order in the direction specified in Column 2 to the said Schedule.
- 2. Nothing in Article 1 of this Order, shall apply so as to prevent any person from causing any vehicle to proceed in the length of road referred to in that Article, if the vehicle is :-
- a) To gain access to adjoining premises;
- b) In an emergency for Fire Brigade, Ambulance or Police purposes;
- c) a pedal cycle, which is not a motor vehicle;
- d) In connection with the carrying out of-
- i) The maintenance, improvement or reconstruction of the said length of road;
- The laying, erection, alteration or repair in, or on land adjacent to the said length of road, of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications network as defined in the Communications Act 2003;
- iii) Building, industrial or demolition operations;
- e) In the service of a local authority, public utility company or the Environment Agency in pursuance of statutory powers or duties;
- f) The vehicle to be used for the purposes of delivering or collecting postal packets as defined in Section 125 of the Postal Services Act 2000.
- The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it

applies for the interpretation of an Act of Parliament.

5. This Order shall come into operation on the XXXX and may

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

Following a successful bid to Welsh Government, Flintshire County Council have been successful in obtaining funding to implement substantial safety measures to address congestion and reduce vehicle speeds experienced along the route to Castell Alun High School.

It is proposed to introduce a Prohibition of Driving, Except for Access on Kiln Lane, Hope, to reduce traffic flow on this road and encourage walking and cycling.


The reduced congestion has benefits for the safety of the children going to and from School and will also improve air quality and quality of life for local residents.
