a) A speed limit of 40mph on:-

Kinnerton Lane:

From a point 258 metres north west of its junction with Main Road to a point 508m north west of its junction with Main Road as shown on Map Schedule N9.

Lesters Lane:

From its junction with Kinnerton Lane to a point 54 metres in a northerly direction, as shown on Map Schedule N9.

In all other respects the present provisions of The Flintshire County Council (Various Roads) (20mph, 30mph, 40mph, 50mph and National Speed Limits. Restricted and Derestricted Roads) Order 2021 will remain in force.

- 4. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the roads specified in the Schedule to this Order.
