# **EXPERIMENTAL ORDER 2022**

Notice is hereby given that on the 1<sup>st</sup> November 2022, Flintshire County Council made an Experimental Order in exercise of its powers under the Road Traffic Regulation Act 1984, under Sections 9, 10 and all other enabling powers, the effect of which will be to:

- Suspend Plan 6 New Street Car Park, in the 'The Flintshire County Council (Off Street Parking Places - Mold) (Civil Enforcement) Order 2018 and replace with 6A
- Introduce a designated Coach Parking Only area within New Street Car Park, Mold as shown on Plan 6B contained within the Experimental Order.

In all other respects the present provisions of the 'The Flintshire County Council (Off Street Parking Places - Mold) (Civil Enforcement) Order 2018' will remain in force.

A copy of the Order which comes into operation on the 4<sup>th</sup> November 2022, together with a plan showing the area affected by the Order and a statement of the Council's reasons for the making of the Order may be examined at Flintshire Connects, Mold Library, Earl Road Mold CH7 1AP during office hours or they may be may be viewed on our website at www.Flintshire.gov.uk > Resident > Roads, Streets and Travel > Traffic Regulation Orders or you can request a copy of the documents by emailing <u>Streetscene@flintshire.gov.uk</u> or by calling 01352701234.

The Council will be considering, in due course, whether the provisions of the Order should be continued in force indefinitely. Within a period of 6 months from the coming into force of the Order, or if the Order is subsequently modified or varied, from the coming into operation of that modification or the variation (whichever is the latest), any person may object to the making of the Order for the purposes of such indefinite continuation.

Objections to the Order, together with the grounds on which they are made, should be sent in writing to the undersigned within six months of the date on which this Order shall have come into force, or the date on which any variation or modification or the latest variation or modification shall have come into force and quoting the reference SS/TRO/JB/OFS/EO/2022.

Any person wishing to question the validity of the Experimental Order (which was made on the 1st November 2022) or any of the provisions contained in it on the grounds that they are not within the powers conferred by the appropriate legislation, or on the grounds that any requirement of such legislation, has not been complied with in relation to the Order may, within six weeks from the 1<sup>st</sup> November 2022, apply to the High Court for this purpose.

The Flintshire County Council (New Street Car Park, Mold) (Prohibition of Driving) (Except Coaches) Experimental Order 2022, sealed on the 18<sup>th</sup> October 2022 shall be amended. The Original Order is hereby amended with the following:-

Within Clause 2 – Article 2 shall now say Article 3 Within Clause 3 – Article 1 shall now say Article 2 Within Clause 7 – Article 1 shall now say Article 6 Date: Friday 4th November 2022
