Notice is hereby given that on the 13th December 2022, Flintshire County Council made an Order in exercise of its powers under the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, Part IV of Schedule 9 and all other enabling powers, the effect of which will be to amend The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013, so as to introduce:-

- 1. 'No Waiting At Any Time' restrictions-:
 - a. At various locations on both sides of Fagl Lane, Hope.
 - b. At the junctions of Wrexham Road with the A550 Wrexham Road, Hope
 - c. At the junction of Fagl Lane with Castell Alun Exit junction, Hope
 - d. At various locations on North East side of Stryt Isa, Hope

In all other respects the present provisions of the 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013' will remain in force.

Flintshire County Council in exercise of its powers under sections 1 (1), 2 (1)(2), 4 (2)(3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") as amended, the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

SECTION 1 - PRELIMINARY

Citation and commencement

- This Order shall come into operation on the 13th January 2023 and may be cited as

 HOPE, (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) (Amendment No. 48) Order 2022
- With effect from the date set out in Article 1 above, Map Schedule AY116 Sheet Revision No: 3 replaces Map Schedule AY116 Sheet Revision No: 2 and all other Map Schedules together with the before mentioned Map Schedules and plans referred to in the Schedules to this Order are incorporated into The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013.
- 3. The interpretation Act 1978 shall apply for the interpretation on this Order as it applies for the interpretation of an Act of Parliament
- 4. For the purposes of this proposed Order, 'Wrexham Road Shall mean the service road that runs parallel with A550 Wrexham Road, Hope.
- 5. In this Order, except where otherwise stated, any reference to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number and any reference to a plan is reference to a plan incorporated in to this order.

PROPOSED PROHIBITION OF WAITING AT ANY TIME

Statement of Reasons for Proposing to make the Order

A successful bid was made to the Welsh Government and as such Flintshire County Council have been successful in obtaining funding to implement substantial safety measures to address a safer off road shared footway and cycleway from Penyffordd to Hope along the A550 Wrexham Road and to help with congestion and reduce unnecessary vehicle movements experienced along the routes to Castell Alun High School.

The Introduction of proposed prohibition of waiting and waiting at any time, will improve safety for pedestrians and all road users through the removal of parked vehicles at key locations, whilst also improving traffic flow around Hope. It will also ensure access is maintained for residents, prevent obstruction, maintain visibility at the junctions and also to ensure that the junctions are not obstructed by parked vehicles.

Parking at junctions, regardless of the presence of yellow lines, is an offence and the restrictions provide a visual deterrent to reinforce this message. At present, should vehicles be parked within 10 metres of a junction, an act of criminality may be committed and would therefore be subject to enforcement action by North Wales Police. Furthermore the Highway Code states that vehicles should not park near or on a junction as they may cause obstruction and compromise safety for all road users.

The County Council continues its responsibility to consider the provision of convenient and safe movement of motor vehicles and other traffic, and the proposed measures are aimed at ensuring that danger is minimised to vulnerable road users aswell as improving the amenities of the locality.
