PROPOSED PROHIBITION OF WAITING AND WAITING AT ANY TIME RESTRICTIONS

Flintshire County Council propose to make an Order in exercise of its powers under the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, Part IV of Schedule 9 and all other enabling powers, the effect of which will be to amend The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013, so as to introduce:-

- 1. 'No Waiting At Any Time' restrictions-:
 - a. At various locations on both sides of Maes Hyfryd, Flint
 - b. At various locations on both sides of Fourth Avenue, Flint
 - c. At the junction of the A5119 Northop Road with Maes Hyfryd, Flint
 - d. At the junction of Third Avenue with Maes Hyfryd, Flint
 - e. At the junction of Fifth Avenue with Maes Hyfryd, Flint
 - f. At the junction of Fourth Avenue with Maes Hyfryd, Flint
- 2. 'No Waiting Monday Friday 8.30am 9.30am and 2.30pm 4.00pm' restrictions:
 - a. At various locations on the Northerly side of Maes Hyfryd, Flint
 - b. At various locations on the East side of A5119 Northop Road, Flint
 - c. At various locations on the Southerly side of Fifth Avenue, Flint

In all other respects the present provisions of the 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013' will remain in force.

Flintshire County Council in exercise of its powers under sections 1 (1), 2 (1)(2), 4 (2)(3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") as amended, the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

SECTION 1 – PRELIMINARY

Citation and commencement

- With effect from the date set out in Article 1 above, Map Schedule AL62 Sheet Revision No: 3 replaces Map Schedule AL62 Sheet Revision 2 and Map Schedule AK62, Sheet Revision No: 2, replaces Map Schedules AK62 Sheet Revision No: 1 and all other map schedules together with the before mentioned map schedules and plans referred to in the Schedules to this Order are incorporated into The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013.
- 3. The interpretation Act 1978 shall apply for the interpretation on this Order as it applies for the interpretation of an Act of Parliament
- 4. In this Order, except where otherwise stated, any reference to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number and any reference to a plan is reference to a plan incorporated in to this order.

PROPOSED PROHIBITION OF WAITING

Statement of Reasons for Proposing to Make the Order

Flintshire County Council propose to introduce No Waiting at Any Time (double yellow lines) and Limited Waiting restrictions (single yellow line), in the roads as listed above.

The No Waiting At Any Time restrictions are intended to address indiscriminate parking, maintain visibility and to ensure that the junctions are not obstructed by parked vehicles.

Parking at junctions, regardless of the presence of yellow lines, is an offence and the restrictions provide a visual deterrent to reinforce this message. At present, should vehicles be parked within 10 metres of a junction, an act of criminality may be committed and would therefore be subject to enforcement action by North Wales Police. Furthermore the Highway Code states that vehicles should not park near or on a junction as they may cause obstruction and compromise safety for all road users.

The Introduction of the Limited Waiting restrictions, will improve pedestrian safety through the removal of parked vehicles at key locations, whilst reducing congestion and improving traffic flow around the School.

In the interests of road safety, the proposals are necessary to avoid danger to people or other traffic using the road, or preventing danger arising.

The proposals are detailed in the Public Notice and in the proposed Order




