STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

Flintshire County Council are proposing to introduce a Prohibition of Driving restriction on Wrexham Road, Penyffordd. For the purposes of this proposed Order, 'Wrexham Road'—shall mean the service road that runs parallel with the A550 Wrexham Road, Penyffordd.

For some time local concern has been expressed regarding anti-social behaviour occurring in the service road which is affecting the amenity and character of the area.

Therefore, it is proposed to prevent through traffic at this location, but will continue to allow the passage of cyclists and pedestrians.

By implementing this Traffic Regulation Order, it will discourage the anti-social behaviour which is detrimental to the amenity and character of the area whilst also improving road safety.

The proposals are detailed in the Public Notice and are contained in the proposed Draft Order.

The Flintshire County Council in exercise of its powers under Sections 1 (1) (d) and (f) of the Road Traffic Regulation Act 1984, ("the Act of 1984") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

- 1. For the purposes of this proposed Order, 'Wrexham Road Shall mean the service road that runs parallel with A550 Wrexham Road, Penyffordd.
- 2. No person shall cause or permit any vehicle except pedal cyclists to drive through Wrexham Road, Penyffordd.
- 3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 5. This Order shall come into operation on the 30th October 2022 and may be cited as The Flintshire County Council (Wrexham Road, Penyffordd) (Prohibition of Driving) Order 2022


